UDSMR® IRF ICD-10 Coder and PPS Coordinator Competency: Putting What You Know to the Test

Simply memorizing codes and applying traditional coding guidelines is not enough; health information management (HIM) coding professionals must understand nonconventional IRF guidelines and know how to use the ICD-10-CM classification system to apply these guidelines to the IRF-PAI.

Coders and PPS coordinators are crucial to this process. The collaboration between the two ensures the integrity and accuracy of the codes recorded on the IRF-PAI and the UB-04, as determined by the physician documentation in the patient's IRF medical record. Understanding IRF-PAI guidelines and ICD-10-CM coding conventions will not only help IRFs capture codes that demonstrate their compliance with the 60% rule, but also help ensure the accuracy of their IGCs, etiologic diagnoses, comorbid conditions, complications, and CMGs. If your staff members don't have the right IRF PPS knowledge and don't understand how to complete the IRF-PAI, your facility could be vulnerable to inconsistencies that result in financial implications
